## TERMS AND CONDITIONS

### Credit Terms:

It is understood and agreed that accounts are due and payable in accordance with the terms granted and stipulated on sales orders and invoices issued from time to time by "Northcoast". A service charge will apply on the amount of any overdue account from the date such account becomes overdue. The current rate is 1.5% per month (18% per annum) subject to change on notification from "Northcoast".

### Purchase of Goods:

The customer shall be deemed to accept absolutely merchandise delivered by "Northcoast" to the customer unless a complaint is made in writing to "Northcoast" by the customer within 48 hours of delivery. Returns are not allowed unless authorized in writing by "Northcoast". Returns deemed by Northcoast to be the customer's responsibility are subject to handling charges of between 15% and 25%.

### Authorization:

The Applicant(s) and, if necessary, the Principal(s) hereby consent(s) to "Northcoast" obtaining such credit reports or other information as regarding the Applicant and/or the Principal(s) as may be deemed necessary in connection with the establishment and maintenance of a credit account or for any other reasonable business requirement, and to exchange such information with other parties when requested. This consent is given pursuant to Section 12 of the Credit Reporting Act RSBC 1979 and the Personal Information Protection Act.

### Withdrawal of authorization:

If the consent as set out above is withdrawn, Northcoast will not be able to assess the credit risk of the Applicant and, as a result, no credit will be provided.

### Forum:

This contract is deemed to be made in Surrey, British Columbia, and any breach of this contract may, at the election of "Northcoast", be litigated in any competent Court in the cities of Surrey or New Westminster, British Columbia.
